CONSENT ITEMS

All items listed under the Consent Agenda are considered to be routine by the City Plan Commission and will be enacted by one motion in the form listed below. - 2. **Site, Landscape and Building Elevation Plans AutoNation Volkswagen** (companion to **Item 4):** A request for approval of a site and landscape plan with building elevations to reflect the demolition of three (3) 10,000 square foot buildings and the addition of a 9,800 square foot showroom to the existing service building. The 7.06-acre site is located at 300 N. Central Expressway, at the northeast corner of N. Central Expressway and Greer Street. Applicant: Paul Padilla, Multatech Engineering, representing 300 North Central LP. *Staff: Israel Roberts*.
- 3. **Site and Landscape Plans Richardson Chrysler:** A request for approval of a revised site and landscape plan to reflect an expansion to the existing showroom and service center building. The 4.8-acre site is located at 1321 N. Central Expressway, at the northwest corner of N. Central Expressway and Monte Blaine Lane. Applicant: Carlos Fernandez, CFA Architects, representing 1321 N. 4. **Replat – North Richardson Addition, Lot 1C, Block 1 (companion to Item 2).** Consider and take necessary action on a request for a replat of Lot 1B, Block 1 and Lot 1C, Block 6 of the North Richardson Addition into one (1) lot. The 7.06-acre site is located at 300 N. Central Expressway, at the northeast corner of North Central Expressway and Greer Street. 5. **Zoning File 14-13 – Palisades:** Consider and take necessary action on a request for a change in zoning from LR-M(2) Local Retail, TO-M Technical Office, and PD Planned Development to PD Planned Development to develop a pedestrian oriented, mixed-use development on approximately 80 acres located on the west side of Central Expressway, generally bounded by Collins Boulevard to the west, Palisades Boulevard and Galatyn Parkway West Extension to the south, and Palisades Creek Drive to the north.
