



2019 Development Submittal Calendar

The following is the anticipated Development Review schedule for 2019. City Plan Commission (CPC) meetings are typically held on the first and third Tuesday of each month at 7:00 p.m. Deadlines for the initial submittal are 30 days prior to the CPC meeting dates. The City Council (Council) typically meets on the second and fourth Monday of the month to consider public hearing items.

Meeting dates listed for each development cycle indicate the first opportunity for consideration by the CPC or Council. Actual meeting dates for an application may change due to application review, CPC and Council agenda case volume, and continuation of public hearings.

Prior to making an Initial Development Submittal, all applicants must schedule a Mandatory Presubmittal Conference with a Planner at least five (5), and no more than twenty (20), working days prior to the anticipated Initial Development Submittal by calling 972-744-4240.
