

RESOLUTION NO. 19-13

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RICHARDSON, TEXAS, CANVASSING AND DECLARING THE RESULTS OF THE GENERAL ELECTION FOR CITY OFFICERS HELD MAY 4, 2019; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, it is hereby found and determined that notice of the election was duly given in the form, manner and time required by law, and said election was in all respects legally held and conducted in accordance with applicable laws of the State of Texas and the proceedings calling and governing the holding of such election; and

WHEREAS, the returns of said election have been duly and legally made and submitted to the City Council for canvassing, and a tabulation of the returns for each polling place and for early voting, as canvassed and tabulated by this governing body showing 6741 ballots cast and each candidate receiving the number of votes as follows:

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF RICHARDSON, TEXAS:

SECTION 1. That said election was duly called, that notice of said election was given in accordance with law, that said election was held in accordance with law, and that it is determined that:

Bob Dubey has been elected Council Member Place 1,
Mark Solomon has been elected Council Member Place 2,
Kyle Kepner has been elected Council Member Place 4,
Ken Hutchenrider has been elected Council Member Place 5,
Steve Mitchell has been elected Council Member Place 6; and
Paul Voelker has been elected Mayor (Place 7)

SECTION 2. That it is further found and determined that in accordance with City Charter, Section 4.08, if no candidate for mayor or a council member shall receive a majority of all votes cast in an election for such office and place, a runoff election shall be called and the names of the two candidates receiving the highest number of votes at the election for the office and place for which they are candidates, shall be printed on the ballot and submitted to the qualified voters for election. It is determined that no candidate for Council Member Place 3 received a majority of the votes and that Janet DePuy and Dan Barrios received the highest number of votes and shall have their names printed on the ballot for a runoff election to be held in accordance with state law.

SECTION 3. That it is further found and determined that in accordance with the order of this governing body, the City Secretary posted written notice of the date, place and subject of this meeting on the bulletin board located in the City Hall, a place convenient and readily accessible to the general public, and said notice having been so posted and remaining posted continuously for at least 72 hours preceding the scheduled time of said meeting.

SECTION 4. That this Resolution shall become effective immediately from and after its passage.
