

**PARKING OF PROHIBITED VEHICLES—NONRESIDENTIAL**

**CHAPTER 22: TRAFFIC**

**ARTICLE IV. STOPPING, STANDING AND PARKING**

**Sec. 22-145. Parking for storage; overnight parking; exceptions.**

(a) Except as provided in subsection (c) of this section, no person shall park for storage any motor vehicle on any street during the hours from sundown to sunup, except vehicles as identified in subsection (c) of this section or temporarily disabled vehicles which are protected by flares or other approved signal devices.

(b) No person shall stop, stand or park any motor vehicle, truck, truck-tractor, trailer, semitrailer, pole trailer or any combination thereof on any street during the hours from sundown to sunup, except temporarily disabled vehicles which are protected by flares or other approved signal devices.

(c) Motor vehicles with a rated capacity of three-quarter-ton or less and with not more than four wheels may be parked on the street during the hours from sundown to sunup.

(d) It shall be unlawful to park, stand or store a box-truck, tow truck, dump-truck, concrete-mixing truck, road tractor, truck tractor, tractor trailer, semi-tractor, trailer, semi-trailer, or similar vehicles, a recreational vehicle, a trailer, or a motor vehicle, truck, van, bus or similar vehicle which is more than twenty-three feet in length, eight feet in width or ten feet in height, during the hours from sundown to sunup on public or private property in any local retail, commercial, office, technical office, mixed use, or planned development zoning districts, except for the purpose of expeditiously loading or unloading passengers, freight or merchandise or vehicles customary and incidental to the operation of a legally permitted business at such location.

(e) It shall be unlawful for the owner, occupant or person in charge of property within the city limits to permit the parking, standing or storing of a box-truck, tow truck, dump-truck, concrete-mixing truck, road tractor, truck tractor, tractor trailer, semi-tractor or similar vehicles; motor vehicles, trucks, or motorcycles; recreational vehicles; or trailers on vacant or unimproved property unless said vehicle is being used in conjunction with an approved construction project.

(f) No owner, occupant or person in charge of a box-truck, tow truck, dump-truck, concrete-mixing truck, road tractor, truck tractor, tractor trailer, semi-tractor or similar vehicle; motor vehicle, truck, or motorcycle; recreational vehicle; or trailer shall park, stand or store the same on vacant or unimproved property within the city limits unless said vehicle is being used in conjunction with an approved construction project.
