CANDIDATE ELIGIBILITY REQUIREMENTS	DEADLINE TO FILE CANDIDATE APPLICATION**	
<ol style="list-style-type: none"> 1. Must be a United States Citizen 2. Must be a registered voter on the date of the election 3. Must be a resident of the City of Richardson for one (1) year prior to the date of the election 4. Must be a minimum of 21 years of age 5. Have not been determined by a final judgment of a court exercising probate jurisdiction to be totally mentally incapacitated; or partially mentally incapacitated without the right to vote 6. Have not been finally convicted of a felony from which the person has not been pardoned or otherwise released from the resulting disabilities 7. Must satisfy any other requirements prescribed by law for the office 8. Candidates must be nominated by petition per City Charter and state law: https://www.cor.net/government/city-secretary/elections/filing-requirements 9. Application and Petition must be filed together by the filing deadline 10. Candidate Packets, including the application and petition are available in the City Secretary's Office the first week of January in odd years. <p>Candidates are strongly encouraged to obtain a candidate packet.</p>	February 12, 2027, by 5:00 PM	
*These forms are available on the Secretary of State website , but the full Candidate Packet (recommended) is obtained from the City Secretary.		
**The filing period begins on the 108 th day prior to the election date and ends on the 78 th day at 5 p.m. prior to the election date.
